

What we do

The Friends is a registered charity established in 1988, and changed a charitable incorporated organisation (CIO) in 2020. Our charitable objects are to support the work of The National Archives and to educate the public in the knowledge of the public record. The National Archives is the official UK government archive for England and Wales. It holds over 11 million records, covering a period of over one-thousand years of documented history.

Since 1988, the Friends' funding and practical support has helped to make many record series more accessible for research. These have included Admiralty, War Office, Chancery, Stationer's Hall, Home Office and other record series. Assistance has also been provided for conservation work and the safekeeping of the collections. The Friends fund and support various education and outreach projects to assist in promoting a wider engagement with new and diverse audiences. Funds have also been provided to enable the collections at Kew to be utilised as the basis for inspiring award-winning film-making, art, drama and literary work by a wide-range of students.

The Friends help to fund conferences and family events, purchase specialist equipment and also promote postgraduate research through a fellowship scheme. The Friends are always looking to extend their activities to fulfil their charitable objects in supporting The National Archives.

How you can help us

Leaving a legacy will help to strengthen the Friends' capability to do more in supporting The National Archives through a wide-range of activities. These include making the collections more accessible, purchasing specialist equipment to assist with conservation, supporting and developing education and outreach projects and events, and sponsoring and promoting postgraduate research.

There are several options in which you can support the Friends through a legacy:

- Make a residuary gift as a share of your estate once your beneficiaries have received their inheritance
- Make a pecuniary gift which is a specific sum of money
- Make a reversionary gift that leaves your estate to your beneficiaries in their lifetime but reverts to the Friends, in whole or in part as you specify, after their death

It would be helpful, and avoid complications, if your legacy is made in general terms rather than stating a specific project or purpose. This is because the Friends' priorities and plans will change over time in response to the changing needs and priorities of The National Archives. It is difficult to accurately predict what these may be in the future. However, if you have a particular general purpose in mind such as, for example, education, research, conservation or increasing document access, then we would be pleased to discuss further with you.

What to do next

If you have not made a will this can cause delay and uncertainty for loved-ones when you die. The laws on intestacy will then determine how your estate is distributed. However, by making a will you can ensure that your exact wishes will be carried out in distributing your estate.




